

Lone Star Statesman


A Texas REALTOR® investing \$250 to \$499 in one year becomes a Lone Star Statesman.

Don't leave class to take a phone call. Your business can wait until a break or the end of the class


Put your devices away unless you are using them to take notes. Wait until a break to return texts and emails.


If you're on a Zoom class, you must remain on camera while class is in session, free of distractions and dangerous behavior such as driving.

Be on time to the start of class, stay in the classroom while class is in session and return on time from lunch/breaks















TREPAC DISCLAIMER: Contributions are not deductible for federal income tax purposes. Contributions to the Texas Association of REALTORS* Political Action Committee (TREPAC) and the Texas Association of REALTORS* Federal Political Action Committee (TAR FedPAC)—which makes contributions to the REALTORS* Political Action Committee (RPAC)—are voluntary and may be used for political purposes. The amount indicated is merely a guideline, and you may contribute more or less than the suggested amount. You may refuse to contribute without reprisal, and the National Association of REALTORS*, the Texas Association of REALTORS* (TAR), and its local associations will not favor or disadvantage anyone because of the amount contributed. Until the RPAC annual goal is met, 70% of an individual's contribution goes to TREPAC and may be used to support state and local candidates; the remaining 30% is sent to TAR FedPAC to support federal candidates and is charged against your limits under 52 U.S.C. 30116. (Exception: 100% of an individual's contribution goes to TREPAC if the individual is an employee of an affiliate member of TAR.)
